#### **CATALOG DESCRIPTION**

An overview course designed to enhance global awareness from a systems perspective. By viewing the world as a single place with interconnected social, political, environmental, economic, and biological dynamics, students are encouraged to recognize the impact of the global in all local contexts, including counseling and education.

#### **COURSE OBJECTIVES**

Students in this course are challenged to develop:

1. A global systems perspective regarding societal changes over the last 500 years;
2. An understanding of the dynamics of colonization, power, and global resource distribution;
3. The ability to relate the global to the local, including placing one's own history and experience within a global perspective;
4. A clarified sense of global responsibility, and its implications for leadership and practice roles in the human services, community development, and education.
5. A complex awareness of issues surrounding global 'helping' projects, from clinical work to 'development' projects.

#### **COURSE REQUIREMENTS AND EVALUATION**

- *Engagement and Participation - 20 points:* Students must complete all assigned readings prior to class to be ready to discuss and apply concepts with colleagues, and be active participants in small group and large group discussions. Students should be prepared to share several insights and several puzzles/questions related to the readings in each class meeting.
- *Weekly reading reports – Submit 6 for 5 points each = 30 points:* Prior to the beginning of class, post on moodle, a page of notes, links to resources, articles, questions/issues, case studies, and other comments based on an hour of research, exploration, etc on the discussion topic for the week. Must include at least one academic source (e.g, journal article, book chapter).

- *Personal Project - 15 points:* Choose a weekly activity designed to develop a habit of global awareness and related action (5 minutes a day or 30 minutes a week). Report on this verbally in class sessions 2, 3, and 4.
- *Preparation of a Global Project Proposal, publishable resource (or substitute project) – 35 points total.* Requirement and evaluation criteria developed collectively in class.
