1. INFO ABOUT HOW NEW TSPC LICENSURE REQUIREMENTS **IMPACT** **THE L&C PRO-AL** **PROGRAM**

What's Changed With Administrative Licensure?

- **Starting August 1, 2022-- THERE WILL BE TWO DIFFERENT ADMIN LICENSE TYPES:**
 - **Principal License**--Required of anyone working as a school building administrator
 - **Professional License**--Required of anyone working at the district level (who supervise TSPC certified staff); Professional License holders can also serve at the building level
 - You can only pursue the Professional License **if you already have a Principal License**
 - See **this document from TSPC** for more detailed information about these two licenses and their renewal requirements.

What Does This Mean About L&C's Current Program?

- The Professional Licensure program at L&C has already transitioned to the **NEW requirements** (pending final TSPC approval in June 2021).
 - **However**, Pro-AL students who were **enrolled in the previous program of study** and are on track to completing by July 31, 2022 **will still be able to complete their programs using the previous requirements**
 - Anyone newly **starting the Pro-AL program Summer 2021 or after** will receive a license that aligns with the new standards
 - New Pro-AL students **do not have to complete** their program by July 31, 2022

2. What If I've Already Been Taking Pro-AL Classes?

This section provides details for students who **already started courses** in the previous Pro-AL Licensure Program

If You Are In the Middle Of Your Pro-AI Program

- You must complete all of your Pro-AI courses + Mentorship **BEFORE JULY 31, 2022**
- Timeline/Terms Left To Complete:
 - Summer 2021
 - Fall 2021
 - Spring 2022
 - Summer 2022 (classes and mentorship completed before July 31)

What If I Have to Re-Enroll/Be Readmitted?

- If you haven't taken a Pro-AI class in over a year, you will have to be **readmitted to the program**. (Click on this link for [readmission process/forms](#)).
- **Before being re-admitted**, the Program Director will review your transcript to make sure that you are ON TRACK to be able to complete your licensure requirements by July 31, 2022.
 - If **ON TRACK**: You will be readmitted and allowed to complete the requirements of the previous program on the condition that you complete before the TSPC deadline
 - If **NOT ON TRACK**: You will be readmitted, but will be asked to complete the requirements of the new program (some old coursework may transfer over but additional courses may be required)

Program Information For Previously Enrolled Pro-AI Students

- **18 Credit Program**
 - **Four Strands, 2 Classes in Each Strand**
 - **A 2 credit Mentorship class**

- **Please Note!** Mentorship is TWO TERMS (Fall to Spring, Spring to Summer)
 - **There is no Summer to Fall Mentorship Section!**
 - **SPRING 2022 is the LAST TERM YOU'LL BE ABLE TO START MENTORSHIP** and finish before the deadline
