Catalogue Description: CPSY 503 Introduction to Professional Counseling

Basic theoretical assumptions of the counseling profession, with an overview of its historical roots, social, cultural contexts, types of practice, ethical principles, and professional orientation.

Required: One 1 ½ inch notebook with plastic cover insert, paper holders and dividers.

No Required Textbook: Readings E-mailed- selected readings

Ethical Guidelines:

Students will obtain a current copy of the ACA Ethical Guidelines for notebook.

Learning Objectives; Guided by the CACREP standards of learning about professional identity. This class will provide an understanding of:

- ❖ History and philosophy of the counseling profession
- ❖ Professional roles, functions, and relationships with other human service providers
- ❖ Professional organizations like ACA, divisions, functions, and services to members
- ❖ Professional credentialing, certification, licensure, accreditation practices, professional organizations, journals and effects on public policy
- ❖ The role of professional counselor in advocating on behalf of the profession
- ❖ Advocacy processes needed to address institutional and social barriers that impede access, equity, and success for clients
- ❖ Ethical standards of ACA and related entities, and applications of ethical and legal considerations in professional counseling

Class Assignments:

1. **Professional Interest Paper:** Write a two to three page position paper describing your interest in the counseling profession, include dynamics of your personal worldview that has informed your decision to become a professional Counselor. Your world view includes but is not limited to the following elements: *physical ability, culture, race/ethnicity, gender, social and political processes, socioeconomic status, exile/migration, religious and spiritual beliefs, language, education, gender, sexual orientation and age*. In the conclusion include some objectives you have for your studies during graduate school. This paper is not formatted in particular style except to use a 12 font 1 & ½ line space. Please include references if you choose to cite particular authors.
2. **One “group quiz” on the history of the counseling profession.** This will be based on a chapter reading and given during class time. A historical timeline will be developed integrating social and political influences on the development of the counseling profession.
3. **Lead/participate in class discussions of readings.**
4. **Library research:**
Go online to the library and find three current articles (2003 and later) that are related to your academic and counseling interests. Hand in the names/authors/date of these articles **as well as four to five sentences about each article.** Do not hand in the copy of the article.
5. **Complete a formatted notebook** containing all pertinent information related to becoming a professional counselor. See attached outline.***

Late Assignments:

Assignments are due at the beginning of class (otherwise considered a day late).
5 point deduction for a late assignment per day.

Make-up Assignments:

Make-up work/plan will be decided before the end of class including the due date. A student cannot move forward into clinical classes until all work is completed.
